3. HAZARDS IDENTIFICATION

No hazardous preparation according to EC-directive 67/548 and 1999/45/EWG and subsequent amendments.

4. FIRST AID MEASURES

General advice : When symptoms persist or in all cases of doubt seek medical advice. Never give anything by mouth to an unconscious person.

After Inhalation : Remove to fresh air.
Keep patient warm and at rest.
If breathing is irregular or stopped, administer artificial respiration.
If unconscious place in recovery position and seek medical advice.

- After Skin contact : Take off all contaminated clothing immediately.
Wash skin thoroughly with soap and water or use recognized skin cleanser.
Do NOT use solvents or thinners.
Put shower on working place
- After Eye contact : Irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart.

- After Ingestion : If accidentally swallowed obtain immediate medical attention.
Keep at rest.
Do not induce vomiting.

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media : Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.
Keep containers and surroundings cool with water spray.
- Extinguishing media which must not be used for safety reasons : Do NOT use water jet.
- Specific hazards during fire fighting : As the product contains combustible organic components, fire will produce dense black smoke containing hazardous products of combustion (see section 10)
Exposure to decomposition products may be a hazard to health.
Cool closed containers exposed to fire with water spray.

7. HANDLING AND STORAGE

Handling

Safe handling advice : Avoid exceeding of the given occupational exposure limits (see section 8).

Avoid inhalation of vapour or mist.

Storage

Requirements for storage areas and containers : Observe label precautions.
Containers which are opened must be carefully resealed and kept upright to prevent leakage.

Store between 5° an 35°C in a dry, well ventilated place away from source of heat, ignition and direct sunlight.
No smoking.
Electrical installations / working materials must comply with the technological safety standards.
